# PRIVACY POLICY

#### **POLICY STATEMENT**

WMS Engineering (WMS) is committed to protecting the privacy of clients and other users of the company's website and services. When WMS is provided with personal information in person, by email, through the company's website or any other forms of communication, WMS will endeavour to ensure that such information remains private and is only used in accordance with this policy. ## USE AND DISCLOSURE OF PERSONAL INFORMATION

WMS holds, uses, and discloses personal information for the following purposes:

- WMS may also seek your consent to collect, hold, use, and disclose your personal information for any other purpose not listed above.

### PRIVACY ON THE COMPANY'S WEBSITE

WMS gathers information and statistics about all visitors to their website, including the most frequently accessed pages and most frequently used services.
